CORRECTION TO THE ENVIRONMENTAL AUTHORISATION ISSUED ON 17 MAY 2021 FOR THE PROPOSED 99MW OYA WIND ENERGY FACILITY (WEF) AND ASSOCIATED INFRASTRUCTURE, BETWEEN MATJIESFONTEIN AND SUTHERLAND IN THE WESTERN AND NORTHERN CAPE PROVINCES

The amendment to the Environmental Authorisation (EA) issued for the above application by this Department on 17 May 2021, the EA correction letter received by this Department on 02 July 2021 and acknowledged on 18 June 2021, refer.
